
LETTER FROM THE DIRECTOR

B lowing in on the March wind is your new *Child Care Chat*, presenting a collection of fresh and exciting training opportunities, and some partnerships and presenters you might not recognize, but I hope you will give them a try. There are also many new training titles to choose from this quarter and something for everyone!

There are a few events that I want to mention here. Wor-Wic Community College, in collaboration with partners you will recognize, is presenting a Child Care Technology Symposium on Saturday, April 14. You can earn 6 COK hours while you learn about how to incorporate technology in your classroom. From the most experienced computer user to a newcomer, there is something for you at this event. There are sessions on how to use Facebook to market vour business, how to promote school readiness using technology, how to create a newsletter to communicate with families electronically and other useful topics. I hope you will come out and support this Symposium. If you are credentialed at a Level 2, you can request a reimbursement of your registration fee.

Something else new is EdCamp. The Lower Shore Child Care Resource Center is partnering with Maryland Public Television (MPT) to bring you a very different approach to professional development that is becoming popular on the education scene. This three-hour session is offered on the SU campus, Conway Hall, first floor. I hope you will be interested in trying another approach to professional development.

Also in the professional development arena, the MSCCA Conference by the Sea is coming up



the first weekend in May. If you have never been to a state-wide conference, you should consider attending this one. It's large, and busy, and right in your own back yard! You will connect with colleagues from across Maryland, earn two Professional Activity Units (PAUs) and can attend classes offering up to 17 hours of MSDEapproved training. I know you will enjoy networking on a large scale.

Another announcement, which may not be new to you, is the arrival of the Reader Van. This is an outreach program by the Wicomico County Library to promote early literacy skills and increase kindergarten readiness. The Reader Van will deliver to your door a large plastic tote full of books and activities based on a theme. There is something for all ages in the tote, so you can pick and choose what best meets your needs. The benefits of this program are many, but most importantly, children have access to books. Take Time to Talk to Infants and Toddlers (3 CD) NEW!

Tuesday, May 8 • 6-9 p.m. Trainer: Pam Hall

Fee: \$30 Non-members/\$20 Members Babies learn conversation skills well before they learn to speak. They engage adults by making noises and use facial expressions to send messages.

Participants in this workshop will recognize the importance of using every opportunity to talk to and sing with infants and toddlers throughout the day to support cognitive development.

Basic Health and Safety Training (3 H)

This workshop will satisfy the pending regulation requiring all child care providers, including all center staff and family providers, to complete this workshop. This three-hour workshop was developed in partnership with the National Center for Early Childhood Health and Wellness, Child Care Aware of America, the American Academy of Pediatrics, and Maryland Family Network, with support from the Maryland State Child Care Association.

CPR and First Aid (no COK)

This is a certification course through American Safety and Health Institute (ASHI). It is strongly recommended to take both CPR and First Aid together. Participants will stay until training is complete – usually three hours. Certification is valid for two years. The next certification course will be offered in July 2018.

Emergency Preparedness for Child Care Providers (3 H, 3 P)



Thank you for abiding by the following training policy. By doing this, you are helping us maintain our high standards and provide the highest quality training:

- You must preregister for all classes. Registration forms can be found on LSCCRC's website, in our newsletter or at our office. Training registrations are on a first-come, first-served basis; register early. You are not considered to be registered for a class until payment has been received in our office.
- Payment for a class should be made payable to Salisbury University. We gladly accept cash, check, Visa or MasterCard. There is a \$25 returned check fee.
- Class registration fees are nonrefundable. However, if you are unable to attend a training session, you must notify our office by close of business the day before the training in order to receive credit towards another class.

- In order to ensure that all classes are conducted as scheduled, please register early. If the minimum registration requirement is not met prior to the class, it will be cancelled. We will notify all registered students of this cancellation.
- In order to get a certificate for training, an attendee will need to be present for the entire training.
- Please be on time for all trainings, as no one will be admitted late. Leaving a training early or arriving late can distract others from learning. Also, taking only a portion of a training does not allow for a participant to get a full grasp of the subject and takes away training opportunities from other providers who need the full amount of training hours.
- Although we love children at LSCCRC, please do not bring them to class with you.

- Certificates will be awarded to all participants successfully completing a class. Please keep these certificates for licensing and credentialing purposes. If you need a duplicate copy of your certificate, you will be charged \$1 per copy.
- Please check with local television stations for any possible cancellations due to bad weather. If a training is cancelled, it will be rescheduled for a later date.
- Please be respectful of the trainer and other class members. Save private conversations for break time or after class. Cell phones, including texting, can be disruptive to others. Please turn your cell phone off at the beginning of class or put it on silent. Disruptive participants will be asked to leave the class and will not be given credit for the class or a refund.

INFANT AND TODDLER MINUTE CHOOSING APPROPRIATE ART MATERIALS FOR TODDLERS

Young toddlers are more interested in exploring and manipulating art materials than in creating works of art. It is not surprising that when introduced to crayons and paper, they may be most interested in touching, looking at and even tasting the art materials. Once children find the marks crayons make on the paper are more interesting than how they taste, then they are ready for art experiences. Even at this point, staff need to provide close supervision and decide how to slowly introduce art materials as children become ready. Below are a list of ageappropriate art materials for our youngest ones.



Young Toddlers (12-23 months of age):

- Large, non-toxic crayons
- Large paper (white and different colors) taped to a surface (table, easel, wall)
- Non-toxic finger paintLarge, non-toxic chalk and chalk boards

Older Toddlers

(24-30 months of age):

- The items listed above for younger toddlers
- Watercolor markers
- Tempera paints
- Painting tools, such as paint brushes of various widths and short handles



- Paper of different sizes and colors
- Easy-to-use blunt scissors
- Unbreakable chalk boards and chalk
- Play dough and simple tools (rollers, plastic or wooden utensils)
- Large self-stick stamps, stickers and tape
- Scrap paper and cut-out pictures for collage with glue sticks
- **Inappropriate Art Materials**

for Toddlers:

- Shaving cream
- Glitter
- Permanent markers
- Items children can choke on such as small broken pieces of crayons, small beads or Styrofoam peanuts

LOCATE COMPLAINT POLICY

Through the LOCATE service, parents share feedback with the LOCATE staff on the programs in the files: licensed child care centers, registered family child care providers, and accredited preschools and camps. While this feedback is at times positive, it sometimes concerns complaints parents have about child caregivers. Of course, LOCATE and the Maryland Child Care Resource Network want to use this information in a way that is fair to providers and parents, while protecting children, as well. Therefore, the LOCATE Complaint Policy was developed and has been in effect since its approval by the Maryland Committee for Children Board in November 1983. According to this policy, all complaints made to LOCATE about child care providers/facilities are recorded. The type of complaint is then determined:

Less Serious Complaint: No Violation: Complaints that do not

involve violations of child care regulations; complaints about situations that do not pose a threat to the safety, health or welfare of a child.

Less Serious Complaint Involving Violation: Complaints of any violation of Office of Child Care (OCC), Maryland State Department of Education (MSDE) regulations and/or the Health Department that do not pose a threat to the health, safety or welfare of a child.

Serious Complaint: Any threat to the immediate health, safety or welfare of a child. When a parent calls LOCATE with a complaint, the referral specialist advises him/her to register the complaint directly with the appropriate regulatory agency and/or Protective Services. Names and telephone numbers of the person with whom the parent should speak are provided. When a Serious Complaint is received concerning one of the providers of facilities in the LOCATE system, no referrals are made by the referral specialists to that provider/facility. The LOCATE director also communicates

with the appropriate regulatory agency personnel about the complaint and maintains the "hold" on the provider/facility until the agency's disposition of the complaint is known. Should the investigation result in no action, the "hold" status is removed from that provider's/facility's records. Should the license or registration be revoked, the record is removed from the LOCATE files. Providers are advised of LOCATE's actions in writing. A provider may appeal the LOCATE director's decision to cease referrals. Appeals are first addressed to the LOCATE Advisory Committee. Final appeals may be made to the board of the Maryland Family Network.

It is the position of LOCATE and MFN that the Complaint Policy is both fair and workable. Safeguards and due process are afforded to the care givers in the files, and parents' and children's rights to safety are addressed, as well.
