Helpful Hints: Potty Training



Potty Training, need I say more? It is a complex process, and it can be tricky to know what the best approach is because every child learns differently, and there is no best way to teach the skills needed.

Here are tips and resources for you to use provided by Pampers on the link below:

Make sure the child is ready.

- Use a sticker chart to track (and reward) progress.
- Use the potty before bedtime and after waking.
- Place the potty in a convenient spot.
- Get on a potty sched-
- Don't expect miracles in a few days.

- Remember regression can happen.
- 8) Don't punish mistakes.
- Have "magic" tricks like having books available to read.
- 10) Give boys extra time.
